

Appendix 9: Trip Permission and Waiver & Release Form

What to bring: Youth should bring a bag dinner, or money to buy dinner on the mountain. Youth should wear proper snow gear that is suited for the mountain winter conditions. If they don't already own proper gear, please notify YFC staff a week in advance, and we will do our best to find them some proper winter attire. If youth have their own equipment (snowboards, skis, boots, helmet, etc) they should bring them. If youth do not have their own gear, we will be trying to find some that fits them, or renting it on the mountain.

What not to bring: Please be advised that we hold a strict no drugs or alcohol policy. If a youth is found with these items while on the trip they will immediately be sent home on a taxi, at the expense of the parent/guardian, and will not be allowed back in the program until the next year, pending YFC staff approval.
